Dobili smo e-mail iz tajništva FIM Europa u kojem nas obavještavaju da je FIM Europa razvila digitalni sistem prijava za natjecatelje na europska prvenstva i kupove, a koji neće biti rukovan od FIM Europa promotora.

Novi digitalni sistem prijava bit će u upotrebi za 2025 sportska natjecanja.

Svi savezi su zamoljeni da o tomu obavijeste svoje vozače, koji će se prijavljivati za natjecanja kroz taj novi digitalni sistem za prijave upotrebom linka – poveznice koja će biti objavljen na prijavnom listu u sekciji koja se odnosi na sport FIM Europa internetske stranice.

Kako će to raditi?

Kada vozač klikne na link na prijavnom listu, morat će kreirati svoj račun (samo kod prve registracije). Jednom kada mu je račun odobren (e-mail link) moći će se prijaviti na izabranu utrku.

Kada vozač kompletira i podnese prijavu, nacionalni savez vozača će dobiti e-mail sa linkom na prijavu kako bi mogao dodati/korigirati CONU licencu (licencu za europsko prvenstvo ili kup) i odobriti ili odbiti prijavu.

Vozač će biti obaviješten putem e-maila kada je njegova prijava odobrena od njegovog nacionalnog saveza.

Službena osoba određena od dotične FIM Europa sportske komisije će dodati/korigirati startni broj vozača. Potom će vozač dobiti finalni e-mail gdje je pisati da je njegova prijava potvrđena te će biti pozvan da konzultira Posebni pravilnik sa svrhom plaćanja startnine (kotizacije za utrku), a kako je u njemu navedeno.

Administrativni pristup FMN-a, organizatora i FIM Europa službenih osoba

Nacionalni savezi, organizatori i FIM Europa službene osobe koji se nisu još uvijek registrirali u sistem prijava, traži se da to učine kroz slijedeći link (PAŽNJA: taj link NIJE za vozače).

Jednom kada kreirate svoj račun, može trajati najviše 24 sata prije nego što se vaš administrativni račun aktivira i tada će te imati pristup sistemu prijava kao administrator. FMN-ovi će moći provjeriti/odobriti prijave

svojih vozača. FIM Europa službene osobe/organizatori ili FMN-ovi organizatori će moći rukovati sa svim prijavama, izvoziti prijavnu listu i sl.

Odjave s natjecanja sa obavijesti

Ako vozač neće moći nastupiti na utrci, on mora otkazati prijavu kroz sistem najbrže moguće, a najkasnije do kraja tehničkog pregleda. Ako nije, FIM Europa će poslati račun sa kaznom od 300 eura.

Nadamo se da će taj sistem pojednostaviti život vozačima (nema papira), nacionalnim savezima (nema obrazac i startnih dozvola koje treba slati) i organizatorima (lista prijava biti će automatski kreirana i ažurirana).

Hvala svima za suradnju.

Molimo sve klubove da pošalju ovaj e-mail svojim vozačima koji imaju namjeru sudjelovati na europskim kupovima i prvenstvima.

Dear Madam, Dear Sir,

FIM Europe has developed a digital entry system for the European Championship and Cup events, which are not handled by a FIM Europe promoter.

This new digital entry system will be used for the 2025 sporting events.

We ask you to inform your riders concerned, to enter for these events through the new digital entry system by using the links to the entry forms published in the sport section of the [FIM Europe website](#)

At this moment following entry forms have been published:

How will it work?

When the riders click on the link to the entry form, they will need to create an account (only for first time registrations). Once they have validated their account (e-mail link), they will be able to enter the chosen event.

When the riders have completed and submitted the entry form, the National Federation of the rider will receive a mail with a link to the entry form in order to add/correct the CONU licence number and approve or reject the entry form.

The riders will be informed by e-mail once their entry form is approved by their National Federation.

An official designated by the respective FIM Europe sporting commission will add/correct the start number of the rider. The rider will then receive a final mail stating that his entry is now confirmed, and he will be invited to consult the Supplementary Regulations in order to settle the payment of the entry fee as mentioned in the SR. The payment is not done through the entry system, but by a separate payment to the bank account of the organizer (see SR).

Administrator access for FMN, organizers and FIM Europe officials

National Federations, organizers and FIM Europe officials who have not yet registered in the entry system are asked to do so, through following link (**attention**: this is link is **NOT** for the riders): Click [here](#)

Once you have created your account, it will take a maximum 24 hours before we activate your administrators' account and that you will have access to the entry system as administrator. FMN's will be able to consult / approve the entries of their riders. FIM Europe officials / organizers or organizing FMN's will be able to consult and handle all the entries, export the entry list, etc.

Absence with notice

If a rider will not be able to attend the race, he needs to cancel his entry through the entry system as soon as possible, but the latest before the end of the technical scrutineering. If not done, FIM Europe will invoice a fine of 300 EUR.

We hope that this system will make life easier for the rider (no paperwork), the National Federations (no forms / no start permission to be sent) and the Organizers (automatic creation of entry lists and daily follow-up of the entries).
